This special track explores Digital Accessibility (DA) for persons with visual, hearing, cognitive, and any other form of physical or learning disabilities in formation, profession, and society. Blindness, deafness, and manual handling disabilities at first sight constitute the most considerable impediments to digital access. Increasingly, also neurodiversity such as autism, dyslexia, ADHD, anxiety disorders, and tourette syndrome, are recognized as requiring special digital formats.

Virtualisation and digitisation, on the one hand, facilitate inclusion of impaired students, employees, and citizens. However, new digital formats and technologies constitute a new source of barrier for participation. Directives and legislations such as from the United Nations and the European Commission have made public sector inclusion mandatory in this domain, with wide ranging future implications for business and industrial organisations.

In formative years, visually impaired and physically disabled disciples and students benefit from experiences of self-efficacy empowered through new assistive devices and programmes, advanced tutoring techniques, and the

use of Industry 4.0 technologies such as 3D-printing and RFID. The possibility to enhance or lower contrast and pace of applications, together with low-stimulus modes, may also remove inherent barriers to participation.

Transition to the work environment is increasingly facilitated as these ancillaries are also available to the non-disabled workforce, for ergonomics and convenience, but also for mental well-being.

Equally, participation in everyday life, social events, and leisure activities is fostered by assistive systems and their increasing ease of implementation, together with a drastically increased awareness in society. These advances in turn help cure the ailments of the ageing society including emerging disabilities in adulthood. They also inform other disciplines such as providing fail-safe manufacturing and logistics, stress-free media, mobility, and administration infrastructure, creating awareness for accessible verbalisation, and lowering psychological barriers to cultural events.

We invite paper submissions addressing these topics.

Example of subtopics for contributions include, but are not limited to:

- Digitally accessible formats for documents, including graphics and websites.
- Accessible administration, operations, citizen self-service, e-health applications, and online business services.
- Augmented reality, 3D prints, RFID- and cyber-physically assisted systems, optical recognition technology, self-learning intelligent assistive devices, both in inclusive and professional scenarios.
- Advanced teaching and training approaches, didactical formats and technologies for students and employees with disabilities, e.g., with focus on STEM disciplines, language studies, or rehabilitation.
- Professional solutions for creating and testing digitally accessible documents, websites, media, learning materials and platforms, and everyday applications.
- Digitally accessible events, media, arts, and performances; digitally augmented experiences.
- IT accessibility issues of the non-disabled ageing workforce.
- Inclusive IT programming and access for digitally illiterate persons.
- Electronic devices and wearables for disabled users.
- Autism- and ADHD-friendly IT applications and media.
- IT for rehabilitation.
- Case studies and best practices in inclusive teaching, assistive technologies, workforce empowerment, interdisciplinary inclusion-related research, and application in specific scenarios.

These are only suggestions; we welcome papers discussing other issues related to digital accessibility
